### **ORDER:**

In the Government Order first read above among others orders have been issued prescribing qualification, remuneration, rules and responsibilities for the posts of Chief Executive Officer, Chief Financial Officer and Company Secretary sanctioned for the Special Purpose Vehicles created for Chennai, Coimbatore, Madurai, Salem, Vellore and Thanjavur Smart Cities.

2. In the letter second read above the Chairman and Managing Director, Tamil Nadu Urban Finance and Infrastructure Development Corporation Limited has stated that the Commissioner, Greater Chennai Corporation has appointed Chief Executive Officer and Company Secretary posts. Other Corporations, except Greater Chennai Corporation are struggling to get suitable candidates for the post of Chief Executive Officer and Chief Financial Officer. The Commissioners Coimbatore, Madurai and Salem Corporations have requested for relaxation in respect of number of years of experience and certain other criteria. He has also stated that the Commissioner of Municipal Administration has suggested certain amendments in the prescribed qualification for the appointment of Chief Executive Officer and Chief Financial Officer.

3. The Chairman and Managing Director, Tamil Nadu Urban Finance and Infrastructure Development Corporation Limited has therefore requested to issue necessary amendments to G.O.(D).No.22, Municipal Administration and Water Supply Department, dated 31.01.2017 with reference to certain prescribed qualifications for recruitment of Chief Executive Officer and Chief Financial Officer for Special Purpose Vehicles of Smart Cities.

4. The Commissioner, Greater Chennai Corporation has also represented to amend certain prescribed qualification for the post of Chief Financial Officer as this post could not be filled up so far.

5. The Government after careful examination, accept the proposal of the Chairman and Managing Director, Tamil Nadu Urban Finance and Infrastructure Development Corporation Limited and the Commissioner, Greater Chennai Corporation and orders the following amendment to the Government Order first read above for the posts of Chief Executive Officer (For Smart Cities other than Chennai), and Chief Financial Officer (For all Smart Cities including Chennai)

**Amendment**

(i). In respect of Academic qualifications and experience for the post of Chief Executive Officer other than Chennai in Annexure-I to the Government order first read above the following shall be substituted:

<b>Age as on 01.11.2016</b>	Age of candidates should not exceed 65 years as on 01.11.2016
<b>Essential Qualification</b>	Graduation in Engineering / Post-Graduation in Engineering / Business Administration from reputed institutions, with atleast 60% marks or equivalent grade point average/ Junior Level Cadre officer having experience in Urban Sector.
<b>Experience</b>	Not less than 3 years of post-qualification experience in managerial capacity in an equivalent or similar position in a reputed organization, of which not less than 2 years in urban sector. International engagement will be considered as an added advantage. In addition to technical competence, equal importance will be given to strategic thinkers, with a developmental mind set, an effective personality and an ability to build external and internal relationships.
<b>Consolidated pay per month (all inclusive on CTC basis) for deserving candidate (90%)</b>	Rs.1.00 Lakh
<b>Performance Linked Pay (10%)</b>	Rs.0.10 Lakh The performance linked pay guideline will be issued separately
<b>Tenure of employment</b>	Initially for a period of three years and will be considered for extension based on performance.

(ii). In respect of Academic qualifications and experience for the post of Chief Financial Officer for all Smart Cities (including Chennai) in Annexure-II to the Government order first read above the following shall be substituted:

<b>Age as on 01.11.2016</b>	Age of candidates should not exceed 65 years as on 01.11.2016.
<b>Essential Qualification</b>	Graduation in any discipline with atleast 60% marks or equivalent grade point average and Member of Institute of Chartered Accountants of India or Institute of Cost Accountants of India or two-years full time Master of Business Administration / Post Graduate Diploma in Management with specialization in Finance from IIMs / IITs or in a reputed institution. Preference will be given to those candidates who are also a Member of Institute of Company Secretaries of India. / Cadre Officers having experience not less than 3 years
<b>Experience</b>	Not less than 3 years of post-qualification experience in managerial capacity in an equivalent or similar position in a reputed organization.
<b>Consolidated pay per month (all inclusive on CTC basis) for deserving candidate (90%)</b>	Rs.50,000/-
<b>Performance Linked Pay (10%)</b>	Rs.5000/- The performance linked pay guideline will be issued separately
<b>Tenure of employment</b>	Initially for a period of three years and will be considered for extension based on performance.
