I. INSTRUCTIONS TO APPLICANTS

BACKGROUND:

Coimbatore Smart City Ltd ("CSCL") is a SPV company formed by the Coimbatore City Municipal Corporation, with the objective of implementing area based development in Coimbatore, under Smart City Mission of Government of India. CSCL's vision for Coimbatore comprises the goals of 1.Rejuvenation & Restoration of a cascading system of 8 Lakes,

2. Conserving and enhancing the built and natural environment
3. Creation of vast public spaces for recreation
4. Promoting active life styles through NMT corridor ensuring health and wellbeing of the Citizens and
5. Creation of a vibrant economy.

The lake front development is central to the realization of the broader vision to make Coimbatore a Smart City. Coimbatore Smart City Limited has proposed to develop boating facilities & water sports in Periyakulam and Valankulam lakes. CSCL has also proposed to operate a Floating Restaurant in Periyakulam Lake. The lake front promenades are developed with Food Courts including in-door & water front seating areas, Food kiosks, Plazas along with Cycling track, footpath with Green space, Floating deck, Rest Rooms, Little mount, Amphitheatre etc. Learning centre, Arts & Crafts village, Children play area, viewing deck, water treatment plant all form part of this water front development. Swale and Mist fountain, Laser shows, Open Air theatre on water for screening movies etc will be added attraction. All these attractions will ensure a consistent increase in the foot fall in the days ahead. These activities are also expected to bring foot fall, all days of the week. Week end crowds thronging this new addition to the City landscape is huge. On an average 6,000 visitors are visiting the Periyakulam lake front alone every day as per an internal census conducted. The Valankulam Lake also receives similar footfalls. The lakefronts are being developed to sport a host of live events to cater to people of all age groups. The Citizens now will have many options to spend their time outdoors in the City. A lot of greenery is being added to create a beautiful ambience. The lakefront is loaded with many features such as places for social and cultural events programmed on a regular basis. Professional management of the facilities & events will bring a rich experience for the visitors to the waterfront.

- 4) The applicants should remit an amount of Rs.5000 (Rupees five thousand only) as Application Fee (Non-refundable) in the form of Demand Draft from any Nationalized / Schedule banks drawn in favor of "The Managing Director, Coimbatore Smart City Limited, Coimbatore" along with the bid.
- 5) The built up space & kiosks will be provided for setting up Food Kiosks outlets covered and open useable spaces for seating in the lake front with common amenities by CSCL.
- 6) All those who meet the eligibility criteria will be short listed after evaluation.
- 7) The successful applicant so enlisted shall not have a right to transfer his registration to any person or persons or concerns.
- 8) The Managing Director, CSCL reserves the right to cancel the enlistment of applicants without giving any notice.

1.0 Enlistment Process in Brief:

The Managing Director, Coimbatore Smart City Limited, Coimbatore invites tenders to enlistment of reputed Food Kiosk operators for operating Food outlets in Valankulam, Periyakulam, Selvachinthamani & Kurichi Lake under Coimbatore Smart City Limited. The applicants will be received upto 3.00 PM on or before 06.03.2023 through offline. The application should accompany **Application Processing Fee of Rs.5000/- (Rupees Five thousand only)** which should be remitted only by way of Demand Draft drawn in favor of "The Managing Director, Coimbatore Smart City Limited, Coimbatore".

Application must reach the office of the Managing Director, Coimbatore Smart City Limited, Coimbatore - 641001 on or before 06-03-2023, 3.00 PM through offline.

The highest bidder for each kiosk will be allotted the kiosk.

3.0 Two Cover System:

The applicant should submit the application in two cover system only.

- Cover A – Should consist of the application and technical documents along with the application processing fee (in form of Demand Draft)
- Cover B – Should consist of the Rental offer by the applicant per month.

4.0 Eligibility, Qualification & Experience:

4.1 Regular Outlets:

The applicant should preferably be a Reputed Regional / Traditional Brand with at least one existing operational store;

- The applicant having at least one existing outlet and having completed at least 1 year operations (S.I. Veg/Non Veg, Chinese, N.I Veg / Multi-cuisine, QSR, Hot/Cold Beverage Bars, Frozen desserts, Snack joints) will be preferred.

2. The applicant should preferably be a registered entity and should enclose attested copies of the following active & valid certificates issued by statutory bodies.
 - a) Proof of Registration as Hotel / Restaurant / Food service outlet
 - b) Proof of Registration of PAN, MSME or any other valid registration.
 - c) Proof of FSSAI Registration / License of State / Central Certification Agency as per Food Safety and Standards Act, 2006 in the relevant field.
3. The applicant having experience in having successfully run the operations for at least past one financial year will be given preference.

Note:

1. The invitation is open to all entities that are either companies registered under Companies Act 1956/2013; or are registered under Societies Registration Act, 1860 or equivalent; or registered as a trust; or is registered under the Indian Partnership Act, 1932 or Limited Liability Partnership Act, 2008 or equivalent and is valid on the date of application.
2. List of enclosures:

Copy of last one year IT Returns, Registration documents of the registered legal entity, Affidavit for no cases pending in any court of law against the applicant entity are also required to be enclosed with the EOI application.
3. Kiosks for retail outlets:

For the applicants who are willing to apply for the Kiosks for retail outlets. FSSAI registration certificate does not apply. The registration certificates such as PAN, Aadhaar & MSME, will suffice.
4. For start-ups or new entrepreneurs relaxation may be considered on a case to case basis.
